An affidavit must be submitted by each sponsor. Please photocopy the affidavit(s), if necessary, and give one to each of your sponsors to complete.
3. Provide the specified documentary evidence for each source of support that you list. Documents must be dated within three (3) months of submitting the Request for I-20 form.

¹ The Master's program costs \$390.00 per credit. A student who completes 27 credits has completed a full academic year. Therefore, \$390/credit x 27 credits = \$10530.00.

² Registration fee= \$50.00 per course * six courses (27 credits) = \$300/year
